- Any complaints/medical concerns refer to receptionist
- Letters are sent to patients who are offenders of missed appointments. After a 3<sup>rd</sup> non compliance they are deleted from the practice list.
- 1 week of a doctors time is wasted every month. Patients to ring or email if they cannot attend.
