1. Welcome – With Yasir unable to attend the meeting Sarah took the 'chair' and welcomed the members and also our speaker Lianna Champ.

2. Guest Speaker

Lianna has been in the funeral business for 35 years and within that time she has worked with all different types of griever. She believes that there are many people living with 'unresolved loss' and has now turned her attention to being a 'grief recovery specialist'. Lianna informed the group that grief is a normal emotional reaction and that people are not given the right tools in which to deal with their grief. Instead they are more than likely to be prescribed anti-depressants. There are also many different types of grief; the loss of grasping normal tasks, terminal illness, divorce, loss of a pet, financial loss, loss of innocence, death, loss of status as someone is diagnosed with dementia they are then grievers etc.

Lianna had found that there was nowhere to go for help and explained that she helped a man who was terminally ill and had he not gone through the programme would possibly have committed suicide.

Lianna has devised a 16 step plan over 8 weeks and people have been able to come off their anti-depressants as a result. They need to know how to cope with losing what's important to them. Lianna has written a book on this subject and she is hopeful that Rio Ferdinand will review it for her. At the beginning of the programme each person makes 3 promises; confidentiality, uniqueness and not to compare/analyse.

All members present thought her course would be of real benefit.

- £25 per session
